Website Privacy Policy of DelGatto Diamond Finance Fund

Del Gatto Finance Group, LP and its related entities, including Del Gatto Finance Group Institutional, LP (collectively, “DGFG”) operate this website, which provides jewelry, diamond, colored stone, precious metals, and timepiece retailers and wholesalers access to DGFG’s services. (NOTE – We have used the new names, which are not yet adopted.)

This page informs website visitors about the collection, use, and disclosure of Personal Information related to the use of or investment in our lending services and the DGFG website (together, the “Service”).

The Personal Information that we collect is used for providing and improving the Service. We will not use or share your information with anyone except as described in this Privacy Policy.

Information Collection and Use

To use our Service, we may ask you to provide us with certain personal information, including but not limited to your name, phone number, and postal and email address. The information that we collect will be used to contact or identify you.

Depending on how you interact with us, we may need to collect information like your bank or other financial account information, passport, and citizenship. We use that information to offer our Service and comply with legal and industry requirements.

Log Data

Whenever you visit our Service, we may automatically collect information that your browser sends to us (Log Data). This Log Data may include information such as your computer's Internet Protocol (“IP”) address, browser version, pages of our Service that you visit, the time and date of your visit, the time spent on those pages, and other statistics.

Cookies

Cookies are files with small amount of data that is commonly used an anonymous unique identifier. Our website uses these “cookies” to collect information and to improve our Service. You have the option to either accept or refuse these cookies, and know when a cookie is being sent to your computer. If you choose to refuse our cookies, you may not be able to use some portions of our Service.

Why we share personal information

We may employ third-party companies and individuals due to the following reasons:

- To facilitate our Service;
- To provide the Service on our behalf;
- To perform Service-related services; or
- To assist us in analyzing how our Service is used.

We want to inform you that these third parties have access to your Personal Information. The reason is to perform the tasks assigned to them on our behalf. However, they are obligated not to disclose or use the information for any other purpose.

Retention Period

When we no longer need to process your personal information for the purposes described in this Policy, we will delete your personal information from our systems. Providing Your Data

Purpose of Processing
